  - ◆ Normal 10,000 (Up to 21 days processing time)
  - ◆ Express 20,000 (Up to 10 days processing time)
  - ◆ Urgent VT 25,000 (up to 3 days processing time)
- Copy of citizenship certificate issued by the Vanuatu Citizenship office
- Copy of confirmation letter issued by the Vanuatu Citizenship office
- Copy of birth certificate for home country
- Copy of FIU clearance Certificate
- Copy of Police clearance of home country
- Copy of National ID card of home country
- Copy of original passport of home country
