CITIZENSHIP ACT [CAP 112]

Citizenship (Capital Investment Immigration Plan) Regulation (Amendment) Order No. 39 of 2024

In exercise of the powers conferred on me by subsections 13C(1) and (3) of the Citizenship Act [CAP 112], I, the Honourable CHARLOT SALWAI TABIMASMAS SARIBO, Prime Minister, make the following Order.

1 Amendments

The Citizenship (Capital Investment Immigration Plan) Regulation Order No. 8 of 2023 is amended as set out in the Schedule.

2 Commencement

This Order commences on the day on which it is made.

SCHEDULE

AMENDMENTS OF THE CITIZENSHIP (CAPITAL INVESTMENT IMMIGRATION PLAN) REGULATION ORDER NO. 8 OF 2024

1 References to "Master Agent and other"

Delete all references to "Master Agent and other Agents" (wherever occurring), substitute "designated agent"

2 Clause 2

Repeal the clause, substitute

"2 Application of this Regulation

- (1) The CIIP under this Regulation is to raise revenue to allow for investment in sectors as set out in the Schedule.
- (2) Investments under the Schedule must:
 - (a) provide employment to citizens of Vanuatu in a manner that must be satisfactory to the Government; and
 - (b) have an impact on the economy of the country, especially through payment of relevant taxes, fees and charges due to the Government."

3 Clause 3

Repeal the clause, substitute

"3 Designated agents for the Capital Investment Immigration Plan

- (1) The Commission is to designate agents to promote and market the CIIP worldwide.
- (2) The Commission in designating an agent under subclause (1) is to, on the recommendation of the Prime Minister, designate a sector under subclause 2(1) that the agent is to promote and market.

3A Quota per annum

A designated agent is to achieve a minimum of 6 investors per annum."

4 Subclauses 5(1)

Delete "Master Agent and other Agents", substitute "designated agents"

5 After subclause 5(1)

Insert

"(1A) An application under subclause (1) will include the applicant's spouse and 2 children."

6 Subclause 5 (2)

Repeal the subclause, substitute

"(1) The designated agents must pay USD 50,000 or AUD 76,000 to the designated Government account."

7 Subclause 5(4)

Delete "USD 1,700 or AUD2,300", substitute "USD5,000 or AUD7,000"

8 After clause 7

Insert

"7A Requirement to provide report

The Commission must provide a quarterly report to the Prime Minister on matters relating to CIIP."

9 At the end of clause 8

Insert
